RATES REFUND TERMS AND CONDITIONS

1. Rates Refund Requests will only be accepted in writing and from:
 - a. the Owner/Ratepayer OR
 - b. A third party with authorised authority to act on the owners behalf OR
 - c. A third party agent (i.e. Managing Agent or Settlement Agent) with FULL authority from the owner;
2. On request the owner/ratepayer, or third party agent must provide verification of the payment such as a copy or original receipt or bank statement showing the rates payment;
3. Credit balances created due to a Direct Debit Arrangement will only be refunded into the account payments were deducted from.
4. A Rates Refund Processing Administration fee of \$11.00 will apply to ALL refunds. The fee will be deducted from the available funds prior to any funds transfer;
5. No fee is applicable to transfer funds between properties;
6. Refunds may take up to 15-20 working days before funds appear in the requesting party's bank account This is dependent on the City's Creditors Department scheduled payment run.
