TSMIT Guide - Breakdown of Total Annual Earning for Each Occupation

Temporary Skilled Migration Income Threshold (TSMIT) concessions includes breakdown of total annual earnings for each occupation i.e. non-cash payments to be included in the salary. Many employer sponsored visa programs, including the standard TSS (Subclass 482), ENS (Subclass 186) and/or SESR (Subclass 494) program, have a minimum threshold that can be paid. The TSMIT which currently sits at \$70,000 also applies.

All workers employed under the DAMA must be employed under Australian employment conditions and receive no less than what an Australian would to undertake the same job in the same location.

The Goldfields DAMA includes access to two types of TSMIT concession across the following occupations:

Concession type 1 - up to a 10% concession to the TSMIT

Businesses must demonstrate the annual monetary earnings provided will be no less than 90% of the TSMIT, i.e. no less than \$63,000.

Concession type 2 - up to a 10% concession to the TSMIT, and the inclusion of non-monetary earnings (other)

Businesses must demonstrate that the annual earnings provided will be no less than 90% of the TSMIT, i.e. no less than \$63,000.

These annual earnings can be comprised of 'non-monetary earnings (other)' to the value of up to \$6,300 annually (i.e. capped at 10% of the reduced TSMIT). Non-monetary earnings (other) refers to benefits such as phone, vehicle, food and board.

Occupations not listed above will not be able request a TSMIT concession.
