## Note: Home Office - Exemption

Clause 4.4(1) Planning approval is not required for the use or development of a home office in accordance with Table 1: Zoning Table. Note: 'Home Office' is defined in Schedule 1 of the Scheme, as below.

Home Office

Means a home occupation limited to a business carried out solely within a dwelling by a resident of the dwelling but which does not:

- (a) entail clients or customers travelling to and from the dwelling;
- (b) involve any advertising signs on the premises; or
- (c) require any external change to the appearance of the dwelling.
