Schedule of Fees and Charges 2025-2026



Definitions

Not for Profit

An entity that carries out activities for a public purpose or an entity whose primary object is not directed at making a profit for distribution or personal gain to shareholders or owners. These may be charities as defined by the Australian Tax Office.

Community Group

A gathering of people with a shared interest, goal, or purpose. These groups are usually run by volunteers, working towards a specific cause or offering services within their community.

Sporting Club

Community sporting clubs are typically non-profit organisations that are not-for-profit entities whose main purpose is to encourage and promote a specific game or sport.

School

A public educational institution as defined by the Australian Tax Office.

Small Business

An entity typically defined as having a turnover of less than \$10 million and fewer than 20 full-time equivalent (FTE) employees.

Corporate / Commercial Business

Any other entity not previously defined above.

Concession

A discount offered to members of the community that hold a recognised concession card or a student card from a public education institution. This includes Pensioner Concession Card, Commonwealth Seniors Health Card, Low Income Health Care Card, Veteran Health Care Card, State Concession Card. To receive a concession, the physical or digital card must be produced at the request of City Officers.

Waivers, Discounts and Concession Authorisation

The Chief Executive Officer is authorised to waive fees, grant discounts or give concessions in relation to the Schedule of Fees and Charges in line with the City's Community Support Policy.
