## PERMIT TERMS AND CONDITIONS

- The portion of Davyhurst/Ora Banda Road affected by the road closure is utilised as a Haul Road by Ora Banda Mining..
- All Applicant details provided on this form will be provided to Ora Banda Mining as the operator of the Haul Road.
- Heavy Vehicles (road trains with a gross combination mass of up to 300 tonnes) operate on the closed road by Ora Banda Mining.
- All drivers accessing Davyhurst/Ora Banda Road must have a valid driver's licence and comply with legal requirements for the safe operation of a vehicle.
- Users must be competent to use UHF radio.
- All vehicles used by the Permit Holder must be roadworthy and registered, have compulsory motor vehicle 'Third Party Liability Insurance' and be fitted with a flashing beacon which must be affixed to the roof of the vehicle and turned on, and UHF radio tuned to the correct channel for the safety of all road users.
- All Permit Holders must obey all road, traffic and radio call-up signs.
- Overtaking is not permitted on the haul road unless directed by a Ora Banda Mining representative.
- Permit Holders should maintain a distance of not less than 50 metres from any Heavy Vehicle when utilising the Haul Road.
- The Road may be closed to Permit Holders in instances where emergency maintenance is required, a safety risk to the permit holder is identified or the road is closed for another reasonable purpose at the determination of the City or Ora Banda Mining.
- Access will not be permitted to permit holders where the road is closed as prescribed in item 10.
- Permits will only be approved for applicants with legitimate and reasonable purpose requiring access to the land.
- Permits are valid not more than Twelve (12) calendar months from date of issue.
- Permits will be reviewed and applicants will receive notice of approval or denial within ten (10) business days.
- Terms and conditions for permit holders may be subject to change.
- Permit holders will be notified of any changes to permit terms and conditions via the email address supplied on this form.
- The Permit Holder indemnifies and agrees to indemnify, defend and hold harmless the City of Kalgoorlie-Boulder and its employees, officers, agents and contractors from and against all loss damage and liabilities that any of them suffer, sustain or incur arising from or in connection with the Permit Holder's access or use of the closed road.
