In accordance with Regulation 17 of the Local Government (Administration) Regulations 1996, voting on matters at the Annual General Meeting of Electors is to be conducted as follows:-

- (1) Each elector who is present at a general or special meeting of electors is entitled to one vote on each matter to be decided at the meeting but does not have to vote.
- (2) All decisions at a general or special meeting of electors are to be made by a simple majority of votes.
- (3) Voting at a general or special meeting of electors is to be conducted so that no voter's vote is secret.

4 OTHER BUSINESS

The Mayor called for questions of the CEO.

Mr David Coulston addressed the Mayor requesting to speak. The Mayor acknowledged the Annual Electors Meeting and electors were able to address Council and ask questions.

Question 1:

Mr Coulston began by discussing the Goldfields Golf Club Committee Meeting on 14 December 2015, specifically the item relating to the Clubhouse Drawings, enquiring as to the procedural process that followed and the sum paid for those and related works.

Response:

The Mayor acknowledged this was the Annual Electors meeting, dealing with 2018/2019 Annual Report, however addressed the question.

The Mayor outlined his recollection of the events.

Cr Brown addressed Mr Coulston confirming he was in attendance at the meeting in question, and verified the details presented by the Mayor.

The CEO addressed Mr Coulston reminding those present the meeting was being recorded. The CEO asked for questions to be targeted to the Annual Electors Meeting and the Annual Report 2018/2019.

Question 2:

Mr Coulston asked what the costs are for flying ex-Deputy Mayor, Mr Pendal, to Kalgoorlie and accommodating him, and what is the fee for him to do this, when the former Mayor is willing to do it for nothing.

Response:

The Mayor stated he would hope it was not for nothing, as a considerable amount of time and expertise would be expended, not only in Kalgoorlie but in Perth also, assisting Council.

The CEO addressed Mr Coulston confirming that the sum of \$15,000 was not an amount being paid to Mr Pendal, however is the total amount available to Council to facilitate independent assistance to its Audit Committee.

Question 3:

Why wasn't a Councillor of 7/8 years invited to the civic reception to thank Cr Pendal. Mr Coulston stated Ms Suzie Williams was also not invited to the Councillors Christmas Party, nor was she thanked for her service.

Response:

The Mayor stated Ms Williams was invited to the reception and declined to attend.

Question 4:

Why did Council run a free event at the same time as the Boulder Markets TomatoFest. The Council excuse given was they were not aware of the Boulder Markets being held.

Response:

The Mayor asked Mr Coulston to confirm the free event he was referring to, in order to assist with answering his question. Mr Coulston did not know what the event was.

Question 5:

What reason was the sale of "glowies" by Boulder Promotions not allowed at the Sunset at the Soundshell.

Response:

The Mayor stated he was advised the Association was invited to sell them and they refused.
