That Council endorse the City of Kalgoorlie-Boulder Youth Strategic Action Plan 2018-2021.

EXECUTIVE SUMMARY

In 2014 the City of Kalgoorlie-Boulder (the City) conducted 'Youth Talk Back Time', a consultation process which led to the development of the City's inaugural plan for young people, the Youth Strategic Action Plan 2014-2017. A review and second consultative program of this plan, branded as 'Youth Talk Back Time 2', was carried out in 2017.

The Youth Strategic Action Plan (YSAP) 2018-2021 is the resulting document that provides a snapshot of what young people in the city look like and the strategic aims and actions the City will undertake to respond to the needs and gaps identified over the next three years.

COMMUNITY STRATEGIC PLAN LINKS

This report links to the Strategic Community Plan through the Community's Guiding Principles for: Investment in the children and youth of the community.

BUDGET IMPLICATIONS

There is an allocation in the City's 2017/18 municipal budget for the Youth Strategic Action Plan. This allocation, Work Order 40210142, is to cover costs associated with the document graphic art and professional printing.

REPORT

In 2014 the City conducted 'Youth Talk Back Time', a consultation process which led to the development of the City's inaugural plan for young people, the YSAP 2014-2017. The initial Plan, funded by the Department of Communities, engaged the views of young people and provided the foundation for service provision, partnerships and events for addressing the needs of young people in the city.

A review and second consultative program of this plan was carried out in 2017. The YSAP 2018-2021 is the resulting document that provides a snapshot of what young people in the city look like and the strategic aims and actions the City will undertake to respond to the needs and gaps identified over the next three years.

The three aims identified by the results of the community consultation are for the City to be more supportive, stimulating and sustainable in how it works with young people. The resulting goals from these aims are for the City to build confidence, grow capability and foster connections for young people. The YSAP expands further on these 3 key areas with objectives, strategies and key actions that the City and Kalgoorlie-Boulder Youth Council (KBYC) will undertake.

These aims were derived from themes found within the consultation results which were then prioritised into broad terms and summarised into the three concise aims. The end result of this process is the provision of a source document to help inform Council decision, to influence planning and respond to the needs and interests of young people in the city.

COMMUNITY ENGAGEMENT CONSULTATION

Consultation was carried out over a six-week period in 2017 through conventional communication channels (newspaper, household newsletters, social media and email). More than 500 persons engaged in the process through these channels as well as through direct engagement in youth-related spaces and workplaces, community and school based workshops and both online and hardcopy surveys.

OFFICER RECOMMENDATION

That Council provide a \$4,000 allocation towards the Urban Shamanics Hip-Hop Workshops from the PCYC Kalgoorlie and Kalgoorlie-Boulder Youth Council Partnership fund.

EXECUTIVE SUMMARY

This report puts forward a proposal for Council to fund a three day hip-hop workshop series provided by West Australian hip-hop artists Urban Shamanics to the amount of \$4,000 from the PCYC Kalgoorlie and Kalgoorlie-Boulder Youth Council (KBYC) partnership fund.

The workshop will be hosted by the PCYC Kalgoorlie and open to 20 young people with participation being free of charge. The three days of workshops are focused on beat making, lyric writing and production techniques. These workshops culminate in participants having an opportunity to showcase their talents at the NAIDOC Week Family Day held at PCYC Kalgoorlie, sharing the stage with a performance by the Urban Shamanics.

COMMUNITY STRATEGIC PLAN LINKS

This report links to the Strategic Community Plan through the Community's Guiding Principles for, "Investment in the children and youth of the community".

BUDGET IMPLICATIONS

There is an allocation in the City's 2017/18 municipal budget for the financial partnership. The proposed funds totalling \$4,000 will be expended from Work Order 40200102 (Youth Partnership Expenses).

REPORT

The KBYC and PCYC Kalgoorlie established a partnership agreement in 2012. The partnership aims to maintain a collaborative working relationship between the two organisations and utilise for the benefit of all young people in Kalgoorlie-Boulder to develop and learn new skills, have a welcome and safe youth friendly environment and to be involved in youth activities, events and programs.

Council officers recommend KBYC in partnership with PCYC Kalgoorlie use \$4,000 of available funding under the agreement for the provision of a three day series of workshops and public performances between 9th to 11th July, 2018, facilitated by the Urban Shamanics hip-hop group artists.

The proposed workshops will be hosted by PCYC Kalgoorlie and culminate in a shared stage showcase between the artists and participants at the NAIDOC Week Family Day event on Wednesday 11th July. Participation with this program will be free of charge for up to 20 young people aged 12 to 25 and run from 9:00am and in to the evening to take full advantage of the artist's time in the city.

The West Australian group known as 'Urban Shamanics' are comprised of musicians MC Jay Skulka, DJ/MC Cable and Aboriginal musician and producer DardyAzz. Focusing on hip-hop styles, the workshops cover all areas that go into making music inclusive of:

- Beat making;
- Lyric writing;
- Song composition;
- Production techniques;
- Performing on-stage;
- Working collaboratively;
- Creative thinking; and more.

As part of the group's development program, the Urban Shamanics also offer participants with on-going mentoring opportunities. Skype, and social media platforms will be utilised to provide remote support for the artistic development of participants and aspiring artists where songs, beats or ideas can be shared for creative feedback. PCYC Kalgoorlie also have plans in place for recurring visits from the group so that they can check-in on local artists and assist in the growth of the city's talent.

The Urban Shamanics hip-hop workshops and continued support systems will provide youth in Kalgoorlie-Boulder with the opportunity to develop the aforementioned skills with professional artists while engaging in a positive activity which contributes to catering to the diverse interests of young people in Kalgoorlie-Boulder.

Having successfully raised \$859.09 by providing assistance at City-coordinated events and programs, the Kalgoorlie-Boulder Youth Council (KBYC) proposes a contribution towards Foodbank WA.

The proposed donation of \$359.09 will go towards the Rumbling Tummies Winter Appeal.

REPORT

KBYC projected to fundraise \$1,500 during the 2017/18 financial year to donate to three local organisations.

At the conclusion of this financial year the KBYC have successfully raised \$859.09 through kiosk sales at the 2017 School's Out Pool Party and volunteering at the City of Kalgoorlie-Boulder's Pets Day Out and Lighting of the Christmas Tree events. Additionally the KBYC collected several boxes of food goods for Foodbank as part of their work at the Santa's Grotto space on Hannan Street in the lead up to Christmas.

To add further value towards the food drive, Foodbank WA has been identified as a worthy recipient of a \$359.09 donation to assist with their Rumbling Tummies Winter

Appeal. This donation will provide approximately 700 children with a meal during the winter months.

Cash donations are invaluable to ensure the warehouse facilities function effectively to maintain food provision services to those in need within the community. Financial contributions from the public and corporate sector provide essential funds to cover the elements that cannot be obtained through physical donations. For every dollar donated to Foodbank for their collaborative supply program they are able to achieve the equivalent of \$7 worth of food.
