#### **EXECUTIVE SUMMARY**

This report puts forward a proposal for Council to fund a hip-hop workshop provided by Australian hip-hop artists Downsyde to the amount of \$1,500 from the PCYC Kalgoorlie and Kalgoorlie-Boulder Youth Council partnership fund.

The workshop will be hosted by the Golfields Art Centre and open to 50 people aged from 12 to 25 with participation being free of charge. The workshop is focused on beat making and lyric writing with underlying themes of collaboration and positivity accompanying areas covered.

# **BUDGET IMPLICATIONS**

There is an allocation in the City's 2017/18 municipal budget for the financial partnership. The proposed funds totalling \$1,500 will be expended from Work Order 40200102 (Youth Partnership Expenses).

#### REPORT

Kalgoorlie-Boulder Youth Council (KBYC) and Kalgoorlie PCYC established a partnership agreement in 2012. The partnership aims to maintain a collaborative working relationship between the two organisations and utilise for the benefit of all young people in Kalgoorlie-Boulder to develop and learn new skills, have a welcome and safe youth friendly environment and to be involved in youth activities, events and programs.

Council officers recommend KBYC in partnership with Kalgoorlie PCYC use \$1,500 of available funding under the agreement for the provision of a two hour hip-hop workshop on the 3<sup>rd</sup> of March, 2018, facilitated by the Downsyde group artists.

The workshop will be provided in collaboration with the Goldfields Art Centre who will host the workshop as part of the Coolio show that evening who will have Downsyde as an opening act. The proposed workshop will be a free event open to 50 people aged 12 to 25 years commencing at 2:00pm.

Focusing on beat making and song writing development the workshop will achieve individual outcomes such as:

- Increased empathy;
- Improved confidence & self-esteem;
- Improved self-respect and self-awareness;
- Reduced stress levels and negativity; and
- Improved levels of concentration, perseverance and commitment.

The workshop also aims to achieve the following group outcomes:

- Musical collaboration:
- · Improved group social skills; and
- Greater understanding of positive group engagement.

The Downsyde hip-hop workshop will provide youth in Kalgoorlie-Boulder with the opportunity to develop the aforementioned skills with nationally recognised artists while engaging in a positive activity which contributes towards catering to the diverse interests of youth in Kalgoorlie-Boulder.

Having successfully raised \$659.09 by providing assistance at City coordinated events and programs, the Kalgoorlie-Boulder Youth Council (KBYC) proposes a contribution towards Save Animals from Euthanasia (SAFE) Goldfields.

The proposed donation of \$500 will assist the organisation to maintain care for animals that need to be re-homed.

# **REPORT**

KBYC projected to fundraise \$1,500 during the 2017/18 financial year to donate to three local organisations.

KBYC have successfully raised \$659.09 through kiosk sales at the 2017 School's Out Pool Party and volunteering at the City of Kalgoorlie-Boulder's Pets Day Out and Lighting of the Christmas Tree events.

Save Animals From Euthanasia (SAFE) Goldfields has been identified as a worthy recipient of a \$500 donation given their work to care for abandoned, injured and neglected animals. Additionally the activities of the organisation promote proper animal management in the City of Kalgoorlie-Boulder.

This charity also raises awareness of the proper treatment and care of animals and manages activities including de-sexing, microchipping, vaccination, worming, flea treatments and advertising ahead of adoption to potential pet owners.

If approved, a cheque will be delivered by the Youth Mayor, Amy Astill to SAFE Goldfields on behalf of the KBYC.
