Tender Shortlist Announced

Three companies have been shortlisted to participate in the tender for the construction of the iconic Kal City Centre Project.

City of Kalgoorlie-Boulder CEO John Walker confirmed Cooper & Oxley, Ertech and MG Group have been invited to tender following a competitive Expression of Interest (EOI) Process last month.

"The shortlisting process was a difficult task due to the impeccable quality of the eight EOI submissions received." Mr Walker said.

"Candidates were scored on their experience, resources and methodology, as well as their strategy for engaging with local contractors and trades to achieve intended outcomes. We believe we have selected the companies most capable of delivering the Project in partnership with these local businesses and Aboriginal enterprises.

Mr Walker said the tender had now been issued, closing on 25 November 2020.

"The shortlisted companies will now be required to validate their local content commitments in the tender to ensure project benefits are shared across the community. Between these outstanding companies and our fantastic local businesses, we are well positioned to achieve a true economic transformation in the heart of our City.

"The shortlisted companies have a wealth of experience in delivering superior public realm projects so it is expected to be a tough competition."

The winning bidder will be announced in mid-December following the completion of the tender evaluation, with construction works scheduled to commence in early 2021.
